THE UCLA AGI HIRSHBERG CENTER FOR PANCREATIC DISEASES PROVIDES A CRITICAL HUB FOR ADVANCING RESEARCH AND TREATMENT BREAKTHROUGHS. WE FUND 3 LABORATORIES AT UCLA FOCUSING ON BASIC AND TRANSLATIONAL SCIENCE. WE FUND A PANCREAS TISSUE BANK.

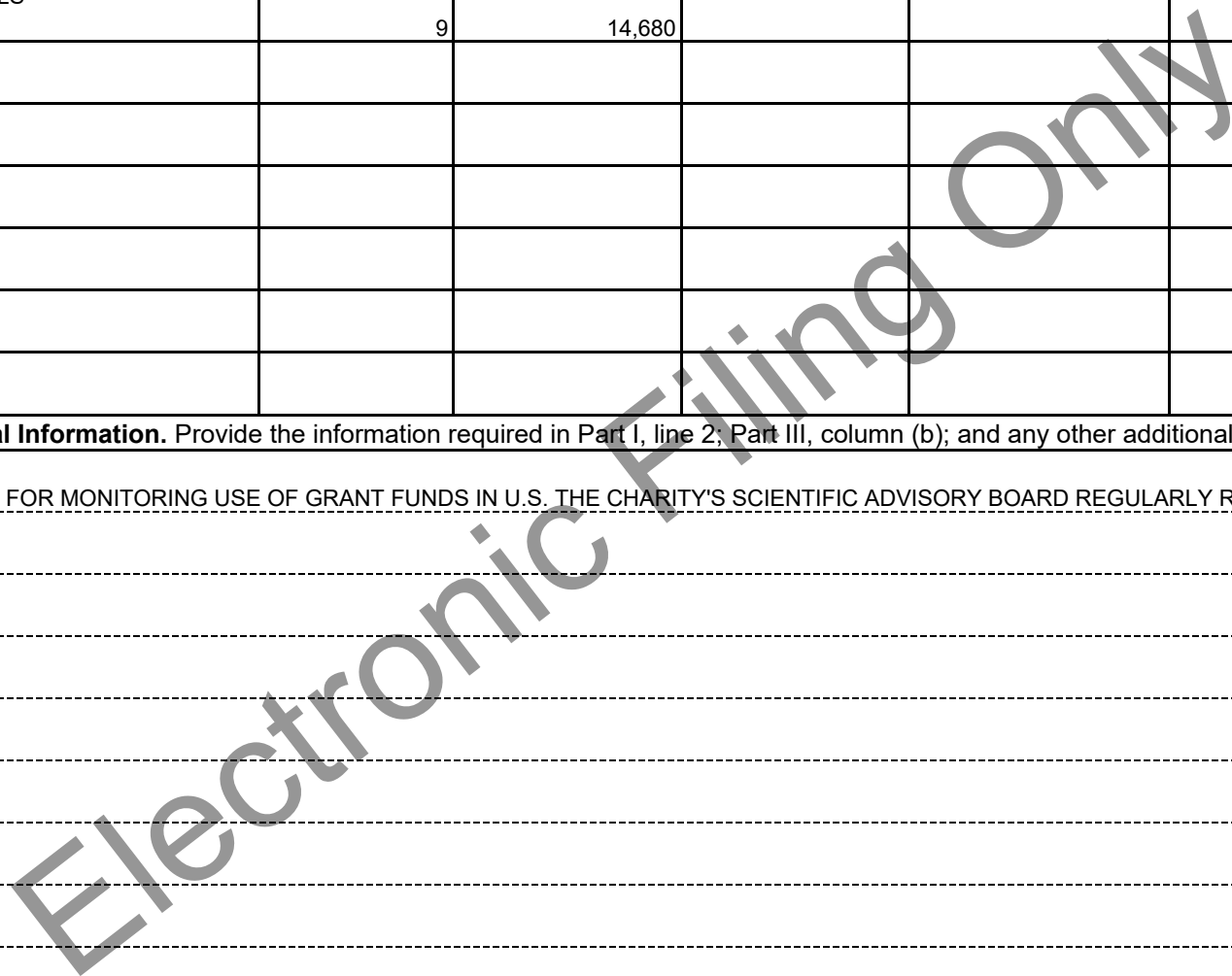
